Ms. Condon retired in 2013 after 30 years of federal government service. She spent sixteen years as a Department of Defense Senior Executive creating, overseeing and administering a broad range of policy, programs and operations including Interagency Coordinator for Military Support to Civilian Authorities for Homeland Security; the first civilian Army Assistant Deputy Chief of Staff for Operations; and the senior civilian for the Army's industrial base, the US Army Materiel Command, and Special Assistant to the Undersecretary of the Army. Her last government position held was the Executive Director of Army National Military Cemeteries where she was recognized as the leader responsible for the complete turnaround of the intensely scrutinized, public scandal at Arlington National Cemetery.

Upon retirement she formed Kathryn A. Condon & Associates, LLC, an independent consulting agency that assists the government and private industry to drive positive change in strategic planning, resource management, fiscal accountability and organizational redesign. Ms. Condon also serves on several corporate boards.

She has a bachelor's degree from the University of Rochester and a Master of Business Administration from Syracuse University.
